Mozelos, June 20, 2012 - In compliance with Section 248.1(a) of the Portuguese Securities Market Act, CORTICEIRA AMORIM, S.G.P.S., S.A. hereby discloses the following information:

1. CORTICEIRA AMORIM, S.G.P.S., S.A., through its subsidiary Amorim & Irmãos, S.G.P.S., S.A., has acquired a 90.91% percent stake in the share capital of TREFINOS, S.L.
2. Located in Girona, Spain, TREFINOS, S.L. is leader in the manufacture and sale of champagne and sparkling wine cork stoppers in Catalonia.
3. With nearly a century of history, TREFINOS, S.L. is a modern and solid organization with a remarkable operational efficiency and profitability. TREFINOS, S.L. has an important international business network in countries like France, Italy and the USA. The outstanding know-how of the Company's directors and officers as well as its investment in R&D applied to technological advance aimed at improving the quality of products should be also emphasized.
4. CORTICEIRA AMORIM thus reinforces its position in the champagne and sparkling wine cork stoppers segment - a priority growth area for CORTICEIRA AMORIM's Cork Stoppers Business Unit - creating significant synergies for the future in terms of production, technology sharing and combining both Companies' complementary sales networks.
5. The inclusion of TREFINOS, S.L. in the CORTICEIRA AMORIM Group will improve its efficiency and strengthen its market position and will allow TREFINOS, S.L. to benefit from the expertise, structures and practices of the

6. The purchase price paid in full on acquisition date was EUR 15,1 million.
7. Once the conditions for this purpose are met, it is in the interest of the Company that Mr Juan Ginesta, the sole director of TREFINOS, SL, will join the Board of Directors of CORTICEIRA AMORIM.
