



About the study



About the study

- The main purpose is to quantify the potential environmental impacts of Amorim Wise Inspire 700 HRT (average specific weight: 7,67 kg/m²; thickness: 7 mm; average composition: 22% cork, 56% recycled HDPE, 6% HDPE, 16% other materials and customization products) produced by Amorim Cork Flooring, through a life cycle approach
- Guidelines: The study was based on ISO 14040/44 series of standards, complemented with the guidelines from the International Reference Life Cycle Data System (ILCD) Handbook General guide for Life Cycle Assessment Detailed guidance
- Approach: cradle-to-grave (from raw material extraction to the product end of life)
- Functional unit: 1 m² of product
- Modelling software and database : SimaPro 9 with ecoinvent 3.5 database
- Method : Midpoint characterization factors recommended by the International Reference Life Cycle Data System (ILCD)
- Data collection procedure



Carbon footprint : results



- Product destination: European market
- End-of-life mix scenario (70% landfill; 10% incineration; 20% recycling)
- ILCD accounts for GHG emissions and removals from Fossil, Biogenic and Land Transformation sources.

Amorim Wise Inspire 700 HRT carbon footprint:

- Cradle to gate: +0,51 kg CO_{2eq}/m²
- ► Cradle to grave: +3,54 kg CO_{2ea}/m²




Maximum ecosystem CO_2 uptake registered (14,7 tCO_2 /ha) (Costa-e-Silva et al., 2015).

Carbon balance: results



Carbon balance reaches up to:

$-101 \text{ kg CO}_{2eq}/\text{m}^2$

Considering:

- Maximum ecosystem CO₂ uptake capacity registered in a well managed cork oak montado in weight-based perspective
- Cradle-to-grave GHG emissions, thus excluding carbon stored and potential future benefits beyond the system boundary.
- Destination: EU scenario
- End-of-life mix scenario (70% landfill; 10% incineration; 20% recycling)
- ▶ 1-year maintenance (for 20 year reference service life adds aprox. +2 kgCO₂/m² in GHG emissions)
